## SECTION II: TERMS OF REFERENCE (TOR) AND SCOPE OF WORK (SOW)

The Government of Uttar Pradesh invites proposals for the Selection of Agency for Implementation of new Emerging Technologies in Disaster Risk Management for the state of Uttar Pradesh. With the aim to compile, implement and present the impacts of disasters on Uttar Pradesh with a special focus on the climate system, hazards in the context of extreme events. The main objective is to explore various options for mainstreaming, best practice and technologies, informed by empirical and scientific assessments, to build strategies to respond to the impact of disasters. Based on new emerging technologies like AI/ML, Block-chain, Artificial Intelligence, modelling one can study the AS-IS report and on the basis of the decision support system can predict the future conditions of the climate that helps to manage the predictive disasters.

#### **INTRODUCTION:-**

- The Office of Relief Commissioner is nodal for effective management, response & relief, rehabilitation, and reconstruction in case of both natural and anthropogenic disasters in the State.
- The Office of Relief Commissioner is also responsible for legislation and policy making about disaster management.
- It also plays an important role in mainstreaming disaster risk reduction into the development plans of concerned departments.

• The Office of Relief Commissioner is responsible to build a safe and disasterresilient Uttar Pradesh by developing a holistic, proactive, multi-disaster and technology-driven strategy for disaster management. This will be achieved through strengthening ongoing efforts in building a culture of prevention, mitigation, and preparedness in state through collective efforts of the government with special focus on most vulnerable communities.

## **OBJECTIVES:-**

- To further strengthen institutional structure of disaster management in the state.
- To undertake effective measures for reducing the impact of natural and man-made disaster.
- To provide prompt & effective rescue operations and transparent relief distribution to affected people.

Uttar Pradesh is prone to multiple hazards which include flood, drought, storms, fire, hailstorms, earthquake and lightning of high severity. More than 40 out of the 75 districts in the state are prone to floods. Areas in western Uttar Pradesh that were historically not flood prone have also started experiencing flooding in recent years. Districts of Terai belt are also prone to earthquake as they fall in seismic zone IV. The state is also prone to drought where Bundelkhand & Vindhya region of state is more prone to drought condition. The state also faces extreme heat and cold wave conditions in peak summer and winter conditions respectively. Lightening, thunderstorm and high-speed winds in parts of the state have also added further distress in the state. These recurring calamities result in substantial annual losses and minimize developmental gains.

## **SCOPE OF WORK: -**

Natural disasters are large-scale geological or meteorological events that have the potential to cause loss of life or property. These types of disasters include:

- Floods
- Lightening
- Drought
- Warnings & other weather data

Earthquakes

These meteorological events are occasionally preceded by presidential "emergency declarations" requiring state and local planning prior to the event, such as evacuations and protection of public assets. Other than above, state also experience deaths due to drowning, snakebite etc.

The scope of the study is to understand and incorporate new emerging technological interventions and innovations into the DRR strategy for minimizing loss and building resilient state.

• POC Approach, Report and Data: The approach of the study will be by raising questions through indicator, attributes and their relationship with natural and anthropogenic causes & make Proof of Concept (PoC) using the latest & emerging technologies. An in-depth and rigorous review of literature and data needs to be carried out on natural hazards in special reference to Uttar Pradesh. The review needs to be done with the State. Secondary data from various databases, reports, departments' maps, etc. as required may be collected and incorporated into the report. The State Government will assign concerned areas for data collection. Finally, all the information will be collated into a synthesis and using new emerging technology for providing policy prescription & preventive action along with implementation framework and monitoring strategies and remediation with a scope of short, medium and long-term interventions.

Note: - The PoC will be carried out for 03 months after selection of the successful bidder/bidders.

**Expected Outcomes -** The findings of the PoC report will inform the department to design policies, programs and draft guidelines addressing the gaps in reducing the impact of climate change.

- The findings of the report will inform the department to design policies, programs and draft guidelines addressing the gaps and overlaps.
- A dashboard to visualize the real time data for development of better Decision Support Systems (DSS).
- Predictive analysis using topological data.
- The findings of the study will provide a substrate for disaster management planning with short, medium, and long-term planning.
